MASTER RATES BYLAW OF THE TOWN OF VIKING, IN THE PROVINCE OF ALBERTA

THE PURPOSE OF THIS BYLAW IS TO AMEND THE ESTABLISH RATES, FEES AND CHARGES FOR GOODS AND SERVICES PROVIDED BY THE TOWN OF VIKING.

WHEREAS, pursuant to the *Municipal Government Act, R.S.A. 2000, Chapter M-26* (hereinafter called the "Act") as amended, a municipal council has broad authority to govern and the authority to pass bylaws respecting the municipality, including services provided by or on behalf of the municipality.

WHEREAS, the municipal council deems it appropriate to establish rates, fees, and charges for the various licenses, permits, goods and services, provided by or on behalf of the Town of Viking.

NOW THEREFORE, the Council of the Town of Viking duly assembled, hereby enacts as follows:

- 1. This Bylaw shall be cited as the "Master Rates Bylaw".
- 2. That the rates, fees and charges for municipal licenses, permits, goods and services are hereby established as identified in Schedule "A" which is attached to and forming part of this bylaw, and any applicable taxes shall be added to these rates at the point of sale.
- 3. That if any provision of this bylaw is deemed invalid, then such provision shall be severed, and the remaining bylaw shall be maintained.
- 4. That this bylaw comes into force and effect on the final reading and adoption and all previous Master Rate Bylaws are repealed.
